

ARTICLES OF INCORPORATION

of

The undersigned Incorporator, for the purpose of forming a professional corporation pursuant to the provisions of Chapter 621, Florida Statutes, hereby adopts the following Articles of Incorporation:

ARTICLE I - Name and Address

The name of this corporation shall be and hereby declared to be CAROLE J. CRANE, PHD., P.A.

The principal place of business of the corporation shall be 1680 Smith Street, Suite 1, Orange Park, Florida 32073.

ARTICLE II - Duration

The period of duration is perpetual.

ARTICLE III - Purpose

The specific nature of business shall be Counseling and Therapeutic Services.

ARTICLE IV - Capital Stock

The corporation shall have one Director initially. The name and address of the initial Director of the corporation is:




ARTICLE IX - Acceptance by Registered Agent


