### ARTICLES OF INCORPORATION

OF

### DROTOS INSURANCE, INC.

THE UNDERSIGNED subscriber to these Articles of Incorporation, a natural person, competent to contract, hereby forms a corporation under the laws of the State of Florida.

#### ARTICLE I - NAME

The name of this corporation is DROTOS INSURANCE, INC.

# ARTICLE II - NATURE OF BUSINESS
