The undersigned, being duly licensed to practice law in the State of Florida, desiring to form a corporation in accordance with Chapter 607 of the Florida General Corporation Act, adopt the following Articles of Incorporation:

ARTICLE ONE

NAME

1.01 The name of the Corporation shall be SOUTHEASTERN CONTRACTING GROUP, INC.

ARTICLE TWO

REGISTERED OFFICE AND AGENT

2.01 The location and address of the Corporation's principal office in Florida is 9420 Lazy Lane, Suite A16, Tampa, FL 33614. The initial registered agent at the registered office is Everett T. Martin, 9420 Lazy Lane, Suite A16, Tampa, FL 33614.

STATED CAPITAL


8.01 The amount of capital with which the Corporation shall begin business is Five Hundred Dollars (\$500.00).




