

#### ARTICLES OF INCORPORATION

OF

#### ARTICLE I

#### Name

The name of this Corporation is TIME OUT SPORTS BAR OF BREVARD, INC.

# ARTICLE II

## Duration

This Corporation shall have perpetual existence.

## ARTICLE III
