ARTICLE 1: NAME AND MAILING ADDRESS

The name of this Corporation is DVDOCTOR, INC., and its principal office or mailing address is: P.O. Box 66212, St. Petersburg Beach, Florida 33736-6212.

ARTICLE 2: DURATION
