### ARTICLES OF INCORPORATION OF NORMA WILLIAMS ADULT FAMILY CARE HOME, INC

#### ARTICLE I--NAME

The name of this corporation is NORMA WILLIAMS ADULT FAMILY CARE HOME? INC.

#### ARTICLE II--DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

#### ARTICLE III--PURPOSE
