The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation:

**ARTICLE I. Name:**

The name of the Corporation is A.S.A.P. OF LEE COUNTY, INC..

The term of existence of the corporation is perpetual.

The corporation shall be deemed to commence its existence on the date of filing of these Articles of Incorporation by the Department of State.

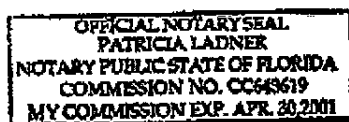

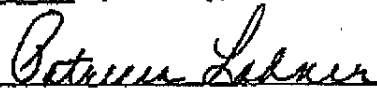
