The undersigned, acting as incorporator of this corporation under the Florida General Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

**ARTICLE I. CORPORATE NAME.**

The name of this corporation is

**POWER SPLASH INC..**

**ARTICLE II. PRINCIPAL OFFICE.**

The principal place of business and mailing address of this corporation are ,  
7026 N. W. 3<sup>rd</sup> Avenue, Boca Raton, Florida 33487.

**ARTICLE III. CAPITAL STOCK.**

The number of shares of stock that this corporation is authorized to have outstanding at anyone time is 100,000 shares of common stock at no par value per share.

The common shares shall be paid for in cash, or property, real or personal, tangible or intangible, or the lease thereof, or in labor or services in lieu of cash or property, at a just valuation to be fixed by the Board of Directors of this Corporation, unless otherwise prohibited by the laws of the State of Florida. The payment thereof does not have to be set at the time of issuance provided such shares are subject to calls thereon by the Corporation until such time as the whole consideration therefor shall have been paid.

**ARTICLE VI. DURATION.**

The corporation shall have a perpetual existence.

**ARTICLE VII. PURPOSE.**

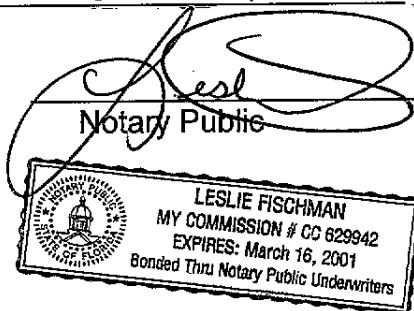


