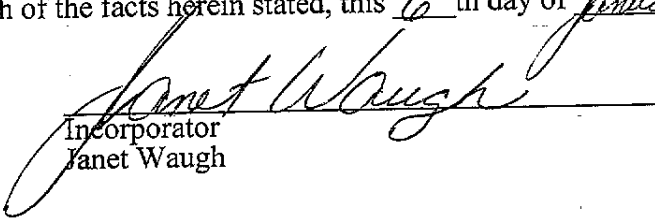
**ARTICLE III - Stock Clause**

**ARTICLE IV - Effective Date**

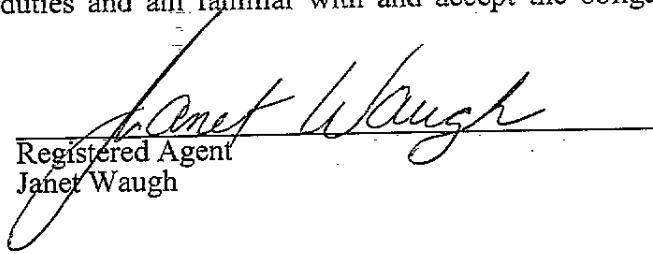
The date that corporate existence shall begin on the date these articles are filed. This election is pursuant to Florida Statute 607.167.
