ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is ADF Business Services, Inc. and the principal address and principal place of business is 9659 135TH STREET NORTH, SEMINOLE, FLORIDA 33776.

ARTICLE II - REGISTERED OFFICE AND AGENT
