**ARTICLES OF INCORPORATION**

**ARTICLE I. NAME**

The name of the corporation is QUOTETHIS, INCORPORATED

**ARTICLE II. ADDRESS**

The address of the corporation is 703 West Platt Street, Tampa, Florida 33606.

**ARTICLE III. DURATION**

The Corporation shall exist perpetually.

**ARTICLE IV. PURPOSE**

This corporation is organized for the purpose of transacting any and all lawful business.

Without limiting or restricting in any manner the general powers of the corporation, and the enjoyment and exercise thereof, as covered by the law of the State of Florida, the corporation shall have the following general powers:

- a. To have a corporate seal, which may be altered at pleasure, and to use the same by causing it, or a facsimile thereof, to be impressed, affixed, or in any other manner reproduced.
- b. To purchase, take, receive, lease or otherwise acquire, own, hold, improve, use and otherwise deal in and with real or personal property or any interest therein, wherever situated.
- c. To sell, convey, mortgage, pledge, create a security interest in, lease, exchange, transfer and otherwise dispose of all or any part of its property and assets.
- d. To lend money to, and use its credit to assist its officers and employees in

accordance with applicable law.

e. To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge or otherwise dispose of, and otherwise use and deal in and with, shares or other interest in, or obligations of, other domestic or foreign corporations, associations, partnerships, or individuals, or direct or indirect obligations of the United States or of any other government, state, territory, governmental district, or municipality or of any instrumentality thereof.

f. To make contracts and guarantees and incur liabilities, borrow money at such rates or interest as the corporation may determine, issue its notes, bonds and other obligations, and secure any of its obligations by mortgage or pledge of all its property franchises, and income.

g. To lend money for its corporate purchases, invest and reinvest funds, and take and hold real and personal property as security for the payment of funds so loaned or invested.

h. To conduct its business, carry on its operations, and have offices and exercise the powers granted by this act within or without this State.

i. To elect or appoint officers and agents of the corporation and determine their duties and fix their compensation.

j. To make and alter bylaws, not inconsistent with its articles of incorporation or with the laws of this State, for the administration and regulation of the affairs of the corporation.

## **ARTICLE V. CAPITAL STOCK**

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 10,000 shares of common stock of one class only, having no par value.

## **ARTICLE VI. PREEMPTIVE RIGHTS**

Every shareholder, upon the issuance of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his prorate share thereof at the price at which it is offered to others.

## **ARTICLE VII. INITIAL REGISTERED OFFICE AND REGISTERED AGENT**

The street address of the initial registered office of this corporation is 703 West Platt Street, Tampa, Florida 33606, and the name of the initial registered agent of this corporation at that address is Clifford Brace Thomasset.

## **ARTICLE VIII. DIRECTORS**

The corporation shall have one director initially. The number of directors may be increased or decreased from time to time, in accordance with Florida Statutes and he by laws adopted by the shareholders, provided, that the corporation shall always have the minimum unber of directors required by law.

## **ARTICLE IX. INITIAL DIRECTOR**

of Directors or by majority vote of the shareholders provided, however, that the Board of Directors shall not have the power to adopt, alter, amend or repeal by-laws if such action would be inconsistent with any by-laws adopted by the shareholders.

#### ARTICLE XII. AMENDMENT

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be by the Board of Directors, proposed by them to the shareholders, and approved at a shareholders meeting by a majority of the shares entitled to vote thereon.

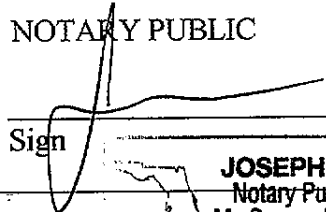

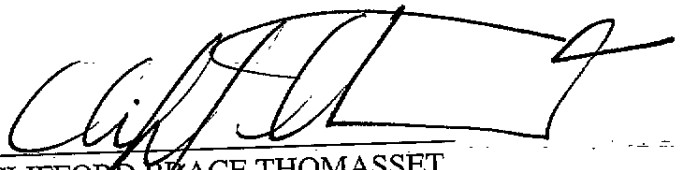

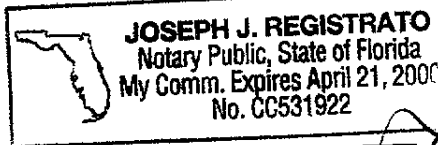
