ARTICLES OF INCORPORATION

The undersigned, incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

ARTICLES I: NAME OF THE CORPORATION

ARTICLE V: AUTHORIZED SHARES

The Corporation is authorized to issue Two Hundred and Fifty Thousand (250,000) shares of common stock with a par value of \$1.00 per share. All stock shall be of one class. 
