ARTICLES OF INCORPORATION OF  
FLORIDA CONSOLIDATED MULTI-MEDIA SERVICES, INC.

1. Name. The name of the corporation is: FLORIDA CONSOLIDATED MULTI-MEDIA SERVICES, INC.
2. Purpose. The corporation may engage in any legal business.
3. Stock. The maximum number and class of shares of capital stock this corporation is authorized to have outstanding is 1,000 shares of voting common capital stock with no par value, and 1,000 shares of nonvoting common capital stock with no par value. The corporation shall have a lien on its shares of stock for any debt or liability incurred to it by a stockholder before being notified of the transfer or levy on such shares.
4. Existence. The corporation shall have perpetual existence. The corporation shall commence existence on the 7<sup>th</sup> day of January, 2000.
5. Registered Agent. The initial street address in the State of Florida of the initial registered office of the proposed corporation is 618 NE 1<sup>st</sup> Street, Gainesville, FL 32601 and the name of its initial registered agent at such address is Steven M. Chamberlain.
6. Location. The business location and mailing address is 3600 N.W. 43<sup>rd</sup> Street, Suite C-1, Gainesville, FL 32606.
7. Management. Business of the corporation shall be managed by the stockholders.

9. Affiliated Transactions. The provisions of Fla. Stat. §607.0901 shall not apply to this corporation.
