ARTICLES OF INCORPORATION  
OF

LAPTOPDOG, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is Laptopdog, Inc.

ARTICLE II

The street address of the principal office of the Corporation is 121 E. Hibiscus Boulevard, Melbourne, Florida 32901.

ARTICLE III

The maximum number of voting shares this Corporation is authorized to issue is 50,000,000 Class A Voting Stock, par value \$.000001 per share, all of which shall be Class A Common Shares. All Class A Common Shares shall be identical with each other in every respect and the holders of Class A Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

The maximum number of non-voting shares this Corporation is authorized to issue is 10,000,000 Class B Non-Voting Stock, par value \$.000001 per share, all of which shall be Class B Common Shares. All Class B Common Shares shall be identical with each other and with Class A Common Shares in every respect except that Class B Common Shares will not be entitled to a vote on matters on which shareholders have the right to vote.

ARTICLE IV

The initial street address of the Corporation's registered office is 121 E. Hibiscus Boulevard, Melbourne, Florida 32901. The initial registered agent for the Corporation at that address is Armando E. Rosal.
