ARTICLES OF AMENDMENT TO AMENDED AND RESTATED ARTICLES OF INCORRORATION OF NEWRESIDENCES.COM, INC.

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act (the "Act"), the undersigned corporation adopts the following Articles of Amendment to its Amended and Restated Articles of Incorporation:

- 1. The name of the Corporation is NEWRESIDENCES.COM, INC. (the "Corporation"), Charter #P0000004718, filed on January 14, 2000 and amended and restated on June 12, 2000.
- 2. The following Amendments to the Amended and Restated Articles of Incorporation were adopted by all of the Directors of the Corporation and all of the Shareholders of the Corporation, the number of votes cast being sufficient for approval, on October 3, 2000 in the manner prescribed by Section 607.1003 of the Act:
- (A) Article I of the Corporation's Amended and Restated Articles of Incorporation shall be amended in its entirety to read as follows:

ARTICLE I

The name of the Corporation is NEWRESIDENCES, INC. (the "Corporation").

(B) Article III of the Corporation's Amended and Restated Articles of Incorporation shall be amended in its entirety to read as follows:

ARTICLE III

The aggregate number of shares of all classes of capital stock that this Corporation shall have the authority to issue is Twenty Six Million (26,000,000), consisting of (i) Twenty Five Million (25,000,000) shares of Common Stock, \$.01 par value per share and (ii) One Million (1,000,000) shares of Preferred Stock, \$.01 par value per share.

3. Except as hereby amended, the Amended and Restated Articles of Incorporation of the Corporation shall remain the same.
