

ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a Corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME; PRINCIPAL OFFICE

The name of this Corporation shall be **HUMAN RESOURCE CONSULTANTS, INC.** (the "Corporation"). The street address and the mailing address of the initial principal office of the Corporation shall be 175 Lookout Place, Suite 110, Maitland, Florida 32751, or such other place as may be designated by the Board of Directors.

ARTICLE II - CAPITAL STOCK

The Corporation shall have the authority to issue 100,000 shares of voting common stock, with a par value of \$0.01 per share.

ARTICLE III - REGISTERED OFFICE; REGISTERED AGENT
