**ARTICLE I - NAME**

The name and address of this corporation is: RMJB, INC., 5200 N.E. 19<sup>th</sup> Avenue, Ft. Lauderdale, Florida 33308

**ARTICLE II - DURATION**

This corporation shall exist perpetually, commencing on the date of filing of these Articles.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any or all lawful business.

**ARTICLE IV - CAPITAL STOCK**

This corporation is authorized to issue 100 hundred (100) shares of one dollar (\$1.00) par value common stock.

## **ARTICLE X - AMENDMENT**

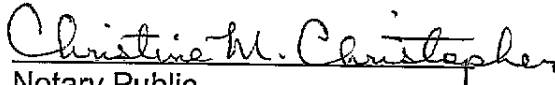
