ARTICLE I - NAME

The name of this corporation is DESTIN COMPUTERS, INC.

ARTICLE II - DURATION

This corporation shall have a perpetual existence commencing on January 3, 2000.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of providing consulting services for computer networking, selling computers and providing computer servicing and for transacting any or all lawful business as allowed under the laws of Florida.
