The undersigned subscriber to these Articles of Incorporation, being a natural person to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I - Name

The name of this corporation is INPRIMIS, INC.

ARTICLE II - Duration

This corporation shall exist perpetually.

ARTICLE III - Purpose

To engage in any activity or business permitted under the law of the United States and the State of Florida.

ARTICLE IV - Capital Stock

This corporation is authorized to issue 20,000,000 shares of one-cent (\$0.01) par value common stock, which shall be designated "Common Shares" and 20,000,000 shares of one-cent (\$0.01) par value preferred stock, which shall be designated "Preferred Shares"


