I represent Schanzenbach, Inc. and Juergen Schanzenbach, the president and sole shareholder, in immigration matters. I just became aware that his corporation had been administratively dissolved and the time period has been just over a year. The reason for the failure of my client to file his annual report is that he never received it. His lease at his former business location was terminated by the landlord on June 11, 2002. All of Schanzenbach's mail was delivered to that business address. By the time the 2003 Annual Report was sent out the post office had stopped forwarding Schanzenbach's mail. It is vital to Mr. Schanzenbach's immigration case that his corporation be reinstated. We would appreciate the reinstatement of Schanzenbach, Inc. and waiving the \$600.00 penalty for the reasons stated.
