OF

ARTICLE I - Name

The name of this corporation is J.C. PULLEN CONCRETE PUMPING, INC. The mailing address and the principal place of business shall be 4342 Old Tampa Highway, Kissimmee, Florida 34742.

ARTICLE II - Duration

This corporation shall exist in perpetuity, commencing on the date of execution and acknowledgment of these Articles.

ARTICLE III - Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - Capital Stock

This corporation is authorized to issue 500 shares of \$1.00 par value common stock.

ARTICLE V - Pre-emptive Rights

Every share holder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share of such stock (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI - Initial Board of Directors

This corporation shall have one (1) director initially. The number of directors may be increased from time to time by the bylaws, but shall never be less than one. The names and addresses of the initial director(s) of this corporation are:

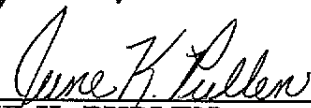
ARTICLE IX - Bylaws

ARTICLE X - Amendment

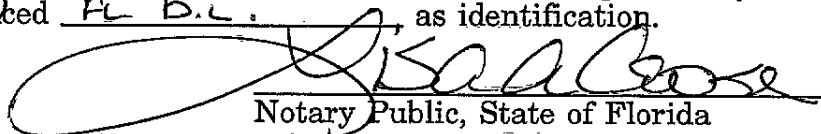

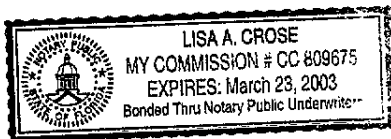
