**ARTICLES OF INCORPORATION
OF
BUSINESS SERVICES NETWORK, INC.**

The undersigned incorporator hereby files these Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the Corporation is Business Services Network, Inc.

ARTICLE VII - BOARD OF DIRECTORS

Section 1: The business of this Corporation shall be managed by a Board of Directors, whose members are referred to herein as Directors.

Section 2: This Corporation shall have one (1) Director initially and the number of Directors may be increased or diminished from time to time as provided for in the By-Laws of this Corporation but shall never be less than one (1).

Section 1. This Corporation shall have a President, a Secretary and a Treasurer and may have additional and assistant officers including, without limitation thereto, one or more Vice Presidents, Assistant Secretaries and Assistant Treasurers. A person may hold more than one office.

Section 2. The officer(s) shall be selected and removed and shall have such rights, privileges, powers and duties as provided for in the By-Laws of the Corporation as may be amended from time to time.

ARTICLE IX - BY-LAWS

The Board of Directors shall adopt By-Laws for the Corporation. The By-Laws may be amended, altered or repealed by the Shareholder(s) or Director(s) in any manner permitted by the By-Laws.

ARTICLE X - AMENDMENT OF ARTICLES

These Articles of Incorporation may be amended, altered or repealed by the Shareholder(s) or Director(s) in any manner permitted by the By-Laws.

ARTICLE XI - TERM

The duration of this Corporation is perpetual.

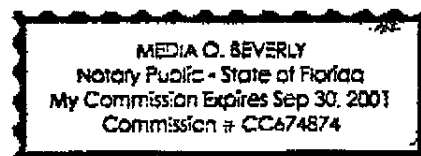
