

ARTICLES OF INCORPORATION

ARTICLE I – NAME AND ADDRESS

The name of this corporation is e title, inc. (the “Corporation”). The address of the principal office and the mailing address of the Corporation is 506 Fleming Street, Key West, Florida 33040.

ARTICLE II – PURPOSE

The Corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE III – CAPITAL STOCK

The aggregate number of shares which the Corporation shall have authority to issue is One Thousand (1,000) shares of common stock, all of which are to have a par value of One Cent (\$.01) per share. The Board of Directors shall fix the consideration to be received for each share. Such consideration shall consist of any tangible or intangible property or benefit to the Corporation, including cash, promissory notes, services performed or written promises to perform services and shall have a value, in the judgment of the directors, equivalent to or greater than the full par value of the shares.

ARTICLE IV – INITIAL REGISTERED

#### ARTICLE V – COMMENCEMENT

The Corporation shall commence on the date on which these Articles of Incorporation are filed with the Secretary of State.

#### ARTICLE VI – INITIAL BOARD OF DIRECTORS

The initial Board of Directors of the Corporation shall be comprised of three persons. The number of directors may be either increased or decreased from time to time as provided for in the Bylaws of the Corporation, but shall never be less than one. The power to alter, amend or repeal the Bylaws shall be vested in each of the Board of Directors and the shareholders of the Corporation.


ARTICLE IX – INDEMNIFICATION
