# ARTICLES OF INCORPORATION OF BUSORTI CORPORATION

SECRETARY OF STATE

The undersigned incorporator to these Articles of Incorporation, a natural person, competent to contract, hereby forms a Corporation under the laws of the State of Florida.

## ARTICLE I.

## <u>NAME</u>
