ARTICLES OF INCORPORATION  
OF  
FMURloc, Inc.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purposes of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is FMURloc, Inc.

ARTICLE II

The Corporation shall exist in perpetuity commencing on the date of the filing of these Articles of Incorporation by the Secretary of State.

ARTICLE III

The street address of the principal office of the Corporation is 1357 Sanibel Lane, Merritt Island, Florida 32952.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 3,000, par value \$.01 per share, all of which shall be Common Shares. All Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE V

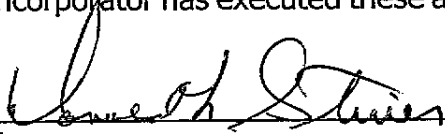

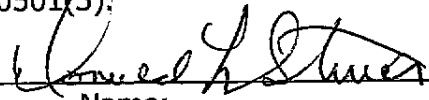
