

## AMENDMENT NO. 1 TO 16 APR -5 AM IO: 34 AMENDED AND RESTATED ARTICLES OF INCORPORATION SECRETARY OF STATE TALLAHASSEE, FLORIDA

## March 28, 2016

F.H.G. Corporation (the "Corporation"), a corporation organized and existing under the Florida Business Corporation Act, as amended (the "Act"), does hereby certify as follows:

FIRST: The name of the corporation is F.H.G. Corporation. The Corporation filed its Amended and Restated Articles of Incorporation with the Secretary of State of the State of Florida on April 28, 2014 (the "Articles of Incorporation").

SECOND: Pursuant to Section 1006 of the Act, this Amendment No. 1 amends the Articles of Incorporation by inserting the following paragraph at the end of ARTICLE V:

"At any meeting of the board of directors, directors elected pursuant to Section 3.4 of that certain Amended and Restated Stockholders Agreement, dated as of December 11, 2015, by and among INI Parent, Inc. and its sharcholders (as may be amended from time to time, the "Stockholders Agreement") will be entitled to cast on all matters voted upon by the board of directors the respective number of votes provided in Section 3.4 of the Stockholders Agreement."

THIRD: On March 28, 2016, the Board of Directors of the Corporation (the "Board") adopted resolutions proposing to amend the Articles of Incorporation as set forth herein.

FOURTH: On March 28, 2016, the stockholders of the Corporation approved the amendment of the Articles of Incorporation as set forth herein with the number of votes cast by stockholders of the Corporation in favor of such amendment was sufficient for approval.

FIFTH: Every other <u>Article</u> and provision of the Articles of Incorporation shall remain in full force and effect.
