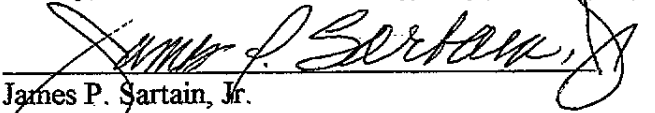

Indemnification

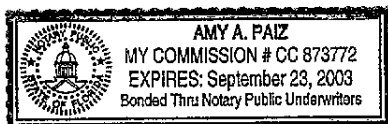

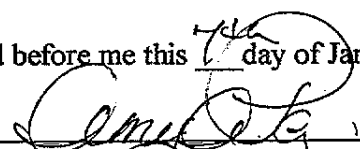

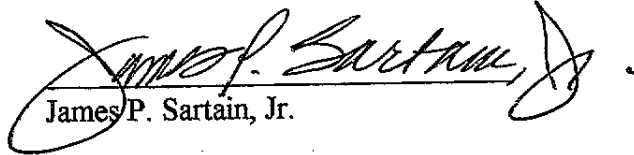
