OF

CORPORATE NAME



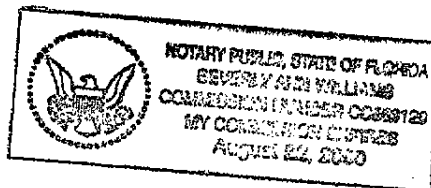
