To Whom it May Concern:

This is a follow up to your letter dated February 25, 2004 regarding the above referenced taxpayer. I spoke to Shawn Toner of your office and he requested we send another letter explaining the facts and to request that the issues relating to our corporation be resolved.

It is my understanding that the taxpayer submitted an annual report July 2003. At that time, though they had not yet received the initial annual report, they submitted the payment of \$550 anyway. They should have requested abatement of the reinstatement fee since the initial report was never received by the taxpayer.

It is my understanding that a correspondence was sent back to the taxpayer requesting the Employer Identification Number. **The taxpayer never received that correspondence.** Accordingly, the State of Florida retained the \$550 where it remains today.

In February 2004, the taxpayer became aware that their corporation had been administratively dissolved. It was at that point that we submitted a Corporation Reinstatement Application along with a check for \$308.75, and a letter explaining that the taxpayer had not received the annual report from the State and asking that the reinstatement fee be waived for that reason. That is what caused you to contact the taxpayer.

In summary, we are asking for you to please reinstate the taxpayer, abate the reinstatement fee since the initial annual report was never received (and since the second annual report, which was mailed to the taxpayer, was never received by the taxpayer. It was only after we initiated contact with the State of Florida, downloaded the form, and sent a payment and a letter, that we found out that the State of Florida had attempted to send the second annual report back to us.
