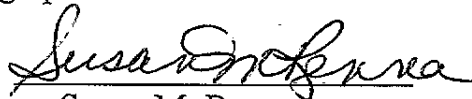
ARTICLE X

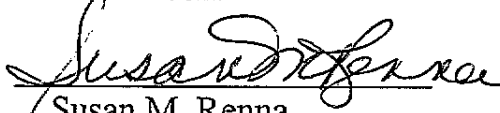
