ARTICLE I NAME

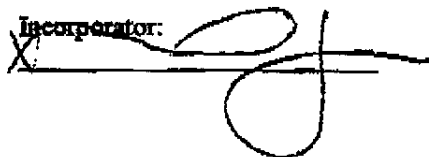

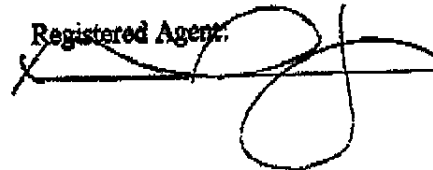
