4.2 Number of Directors.

The Board of Directors of the Corporation shall consist of one or more members. The number of Directors shall be fixed by, or in the manner provided in the By-Laws, except as to the number constituting the initial Board of Directors, which number has been fixed by these Articles of Incorporation.
