**ARTICLES OF INCORPORATION
OF
VHF Mobile Relay, Inc.**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is VHF Mobile Relay, Inc.

ARTICLE II

The existence of the Corporation shall begin on January 5, 2000.

ARTICLE III

The street address of the principal office of the Corporation is 1461 Banks Road, Margate, Florida 33063.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 1,000, par value \$.01 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE V

The initial street address of the Corporation's registered office is 1881 N.E. 26 Street, Suite 40, Fort Lauderdale, Florida 33305. The initial registered agent for the Corporation at that address is Bruce H. Little.

ARTICLE VI

The initial board of directors shall consist of 2 members. This number may be increased or decreased from time to time in accordance with the Corporation's bylaws, but shall never be less than one. The names and addresses of the persons who will serve on the initial board of directors are:


