Authorized capital stock may be paid for in cash, services or property Corporation at any regular or special meeting.


ARTICLE VI - AGENT:


ARTICLE IX - INDEMNIFICATION:

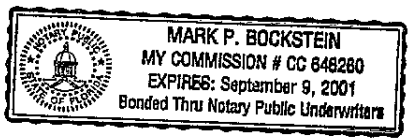
