

ARTICLES OF INCORPORATION
of
Manatee Maintenance Services, Inc.

The undersigned, for the purposes of forming a corporation under the Florida Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

ARTICLE 1 NAME

The name of the corporation is:

The duration of the Corporation is perpetual.


ARTICLE 9 INDEMNIFICATION




