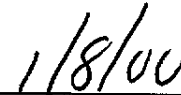
ARTICLE VI - DURATION OF EXISTENCE

This corporation shall transact or engage in any trade, business or activity permitted under the laws of the State of Florida and the United States of America.

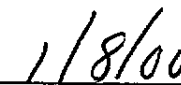
