

I, the undersigned subscriber to these Articles of Incorporation, do hereby form a corporation for profit under Chapter 607 of the laws of the State of Florida, as follows:

**ARTICLE I: NAME**

The name of the corporation shall be POWER BOAT SPECIALISTS, INC. The address of the principal office of this corporation shall be 3115 Mercer Road, Bradenton, Florida 34207 and the mailing address shall be the same.

**ARTICLE II: NATURE OF BUSINESS**


