ARTICLES OF INCORPORATION
OF
OKALOOSA COUNTY AFFORDABLE HOMESIGHTS, INC.

ARTICLE I - NAME

The name of this corporation is OKALOOSA COUNTY AFFORDABLE HOMESIGHTS, INC.

ARTICLE II - DURATION

This corporation shall have a perpetual existence commencing on January 6, 2000.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of land acquisition and rentals and all-lawful business as allowed under the laws of Florida.

ARTICLE IV - CAPITAL STOCK
