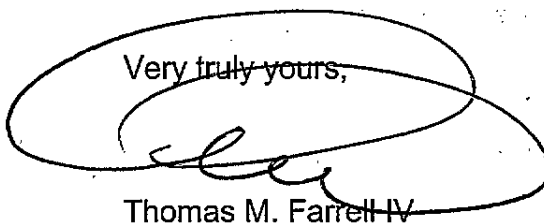

**ARTICLES OF INCORPORATION
OF
THE MAIN EVENT SPECIAL EVENT CONSULTANTS, INC.**

ARTICLE I - NAME

This corporation shall be known as The Main Event Special Event Consultants, Inc.

ARTICLE II - PURPOSE

The purpose for which this corporation shall exist to engage in any activity of business permitted under the laws of the United States of America and the State of Florida.

The corporation elects to become a small business concern under Subchapter S of the Internal Revenue Code of 1954.

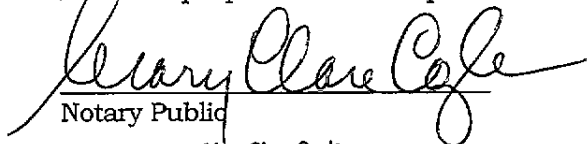

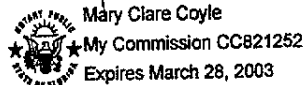
