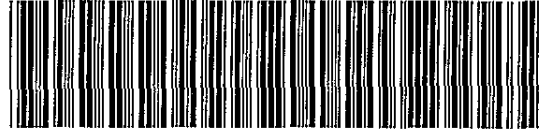

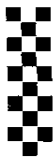


A special meeting of the Board of Directors of Resort Realestate, Inc., was called to order on September 24, 2003 at 9:00A.M. at the principal place of business.
