ARTICLES OF INCORPORATION OF ETHICAL DIVORCE PLANNERS, INC.



ARTICLE I

The Corporation and its stockholders, or the stockholders of the corporation among themselves, may enter into any agreement restricting the transferability, assignment, encumbrance or pledge of the stock of this corporation, whether voluntarily or involuntarily.
