In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the corporation ("Corporation") is **ALL STATES AUCTIONEERING, INC.**

**ARTICLE II**

The existence of the corporation shall begin on the date of filing and be perpetual.

**ARTICLE III**

The street address of the principal office of the Corporation is **4543 Southwest 15<sup>th</sup> Avenue, Cape Coral, Florida 33914.**

**ARTICLE IV**

The maximum number of shares this Corporation is authorized to issue is 1000, all of which shall be Common Shares.
