

The undersigned, David Hambrick, subscriber and incorporator to these Articles of incorporation, as a natural person competent to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

#### ARTICLE I - NAME
