ARTICLE I - NAME AND ADDRESS

The name of the Corporation shall be CORRUGATED CONCEPTS, INC.
with its principal place of business at 3779 Northeast 33rd Street,
Ocala, Florida 34479.

ARTICLE II - NATURE OF BUSINESS

This Corporation may engage or transact in any or all lawful
activities or business permitted under the Laws of the United

ARTICLE VI - BOARD OF DIRECTORS


