#### ARTICLE I

The name of the corporation is Stewart & Stewart Company (hereinafter called the "Corporation").

# ARTICLE II

The address of the principle office and the mailing address of the Corporation is 18801 West Oakmont Drive, Hialeah, Florida 33015

#### ARTICLE III

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:
