ARTICLES OF INCORPORATION

OF

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation, under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is Sussex Homes of Florida, Inc. and its principal office and mailing address is: Greentree Professional Center, 10641 Airport Road South, Naples, FL 34109.

ARTICLE II - NATURE

The nature of the business to be transacted by this corporation is:
residential building construction. To erect dwellings, apartment houses and
other buildings, private or public, of all kinds, and to sell or rent the same. To lay
out, grade, pave and dedicate roads, streets, avenues, highways, alleys, courts,
paths, walks, parks, cemeteries and playgrounds. To buy sell, mortgage,
exchange, lease, let, hold for investment or otherwise, use and operate real
estate of all kinds, improved or unimproved; and any right or interest therein.
