ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION

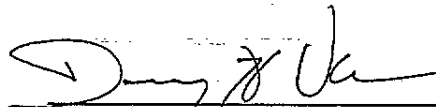

ARTICLE I be and hereby is amended to read as follows:

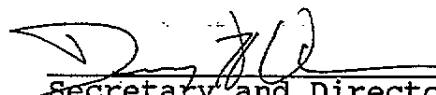
"The name of this Corporation shall be VARNER & THORNE, P.A."
