I, the undersigned, do hereby make, subscribe, acknowledge and the these Articles of Incorporation with the Secretary of State of the State of Florida for the purpose of becoming a corporation for profit under the laws of the State of Florida.

#### ARTICLE I

The name of the Corporation shall be REIZO ENTERPRISES, INC.

#### ARTICLE II

This corporation is to have perpetual existence, unless dissolved sooner according to the laws of the State of Florida.

#### ARTICLE III

The general nature of the business and the objects and purposes proposed to be transacted and carried on by this corporation shall be as follows:

A. To purchase, or in any way acquire for investment or for male or otherwise, lands, contracts for the purchase or sale of lands, buildings, improvements, and any other real property of any hind or any interest therein, and as the consideration for same to may cash or to issue the capital stock, debenture bonds, mortgage honds or other obligations of the corporation, and to sell, convey, lease, mortgage, deed in trust, turn to account, or otherwise deal
