

Article 1.

The Corporate Name

The corporate name of this corporation is:

Article 2.

Nature of Business

The nature of the corporate business and purposes is any businesses not prohibited by the law of the State of Florida and by the Federal law. Corporate Directors

- 4.1. The number of Directors of this corporation may increase or diminish as needed according to the laws and upon the approval of the stockholders and shall never be less than 1 (one).
- 4.2. The Corporate Directors in addition to the power conferred by the laws of the State of Florida, have the power to make, alter, amend and repeal the by-laws, and to apportion any funds of the corporation available for dividends as a reserve for any proper purpose, and to alter or abolish such reserve as needed. The corporation reserves the right to amend, alter, change or repeal any provisions contained in this Corporate Articles in any manner now or thereafter prescribed by law, and all rights conferred on officers, directors and stockholders herein granted subject to this reserve.
- 4.3. Shareholders are appointed Board of Directors.
- 4.4. Board of Directors are voting President, Vice-President and other corporate officers.
- 4.5. All or any commercial, business and other proposals are adopting by the Board of Directors and approving by President.


