Article 1

Name

The name of this corporation is:

Article 2

Effective Date and Duration

This corporation shall exist perpetually commencing as of the date of the filing of these Articles of Incorporation of record by the Florida Department of State.

Article 3

Purposes

This corporation may engage in any activity or business permitted under the laws of the United States of America and of this State.

Article 4

Capital Stock

This corporation shall be authorized to issue ONE THOUSAND (1000) Shares of Common Stock, each having a par value of ONE DOLLAR (\$1.00). All the shares of the Common Stock shall have equal rights and privileges and shall be entitled to ratably receive the net assets of the corporation upon dissolution.

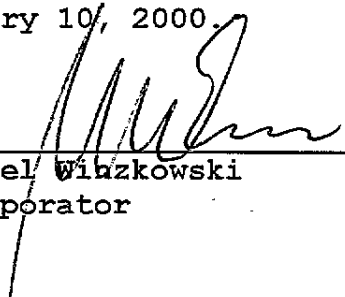
Article 9

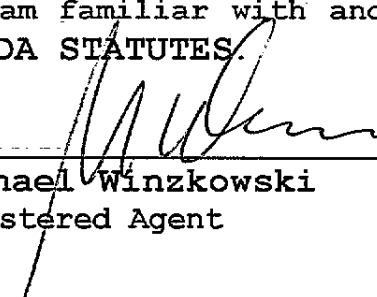
